NOTICE inviting Response to EOI for Selection of Managed Service Provider (MSP) for setting up and managing Tax Information Network (TIN) for accepting TDS/TCS Statements, TAN/AIN applications, Receiving Data Related to Tax Payments for Income Tax Department.

Income Tax Department (ITD) Intends to engage a Managed Service Provider (MSP) to develop, operationalized and manage Tax Information Network (TIN).

TIN includes:-

- a: Setting up of TIN-FCs across country to receive TAN applications, TDS Statements in electronic and paper form, 24 G Statements in electronic form, AIR Statements in electronic form.
- b: Acceptance, validation, transmission and storage of electronic data received through TIN-FCs in TIN Central System.
- c: OLTAS (receiving, storing and organizing the information relating to tax payments and refunds uploaded by the designated banks).
- d: Collating and transmitting the electronic data received in the TIN project to ITD system within defined time period from the time the same is received in TIN Central System.

Detailed Scope of Work has been included in the EOI document. Desired features of the solution is also detailed in the EOI document.

1. The **Pre-qualification Criteria**s for the bidder have been mentioned in the EOI document and need to be adhered to in order to be considered.
